



**Thermo Products, LLC. "PEACE OF MIND" Warranty (Limited)
Gas Furnace
Ten-Year Parts and Transportation Lifetime on Heat Exchanger**

Thermo Products, LLC., a Delaware corporation, hereby warrants the Thermo Pride gas condensing warm air furnace manufactured by it to be free from defects in material and workmanship. The warranty is extended to the original owner(s) whose name(s) appear on the Warranty Registration submitted to Thermo Products, LLC. The heat exchanger warranty is also extended to any subsequent owner(s). Thermo Pride gas furnaces include a 10-year Peace of Mind Plus Limited Warranty. If the heat exchanger fails due to manufacturers defects within 10 years from the date of installation, we will provide a replacement furnace upon verification of warranty status. Installation requirements must be met. After the tenth year, the heat exchanger continues to be covered by our transferable Lifetime Limited Warranty.

1ST-10TH YEAR: During the first 120 months after installation, all parts of the furnace are warranted with the exception of air filters. The owner may arrange with the original installing contractor or any other qualified contractor of his choice to replace the defective part. Any labor costs involved in furnace diagnosis, service or the removal and replacement of a defective part are the responsibility of the owner. Warranted replacement parts will be shipped with instructions to the contractor on disposition of the defective part. Beyond the fifth year, any transportation costs associated with the replacement of warranted parts are the responsibility of the owner. Beyond the tenth year, no other parts are covered except the furnace primary and secondary heat exchangers. The 10-year parts warranty is extended to the original owner only.

BEYOND THE 10TH YEAR: The primary and secondary heat exchangers carry a Limited Lifetime Warranty. If at any time during the warranty period the primary or secondary heat exchanger becomes defective, Thermo Products, LLC. will provide at its option either a replacement heat exchanger or the necessary repair parts on a no charge basis. Any labor costs involved in the diagnosis, repair or the removal and replacement of a heat exchanger are the responsibility of the owner. The owner may arrange with any qualified HVAC contractor for the necessary labor. Beyond the fifth year, any transportation costs associated with the replacement of the complete heat exchanger or the repairs parts are the responsibility of the owner. If Thermo Products, LLC. requests the return of the defective heat exchanger after the fifth year, it must be returned by prepaid transportation at the expense of the owner.

THE CONDITIONS OF THIS WARRANTY ARE:

- A. The owner must submit the warranty registration within ninety (90) days of installation to activate warranty coverage. If the warranty registration is received after the ninety (90) day period, the date of installation will be considered the ninetieth (90th) day after the date the unit was sold to the contractor.**
- B. The furnace must be operated within its rated capacity as indicated on the rating label and fired with the fuel for which it was designed.
- C. The furnace must be installed, set up and maintained by a qualified technician in accordance with local and state codes and/or Thermo Products, LLC installation and operation instructions. The furnace must have been provided reasonable and necessary maintenance.
- D. The furnace must operate with a duct system designed in accordance with the current ACCA (Air Conditioning Contractors of America) Manual D recommendations.
- E. Failure caused by any third party product, service, or system connected or used in conjunction with the furnace may void warranty.
- F. The furnace must not be installed in any structure with a corrosive atmosphere or have contact with corrosive materials such as but not limited to salt, chlorine, fluorine, sulfur, recycled waste water, urine, fertilizers, rust, or other damaging substances or chemicals.
- G. Limit controls and pressure switches which are supplied with the furnace and having pre-set temperatures or pressure settings must not be modified, altered or by-passed.
- H. The furnace cannot be modified and/or operated in any manner other than its design configuration.
- I. No air conditioning or heat pump coil may be installed on the return air side of the furnace.
- J. The furnace must be protected against freezing.
- K. The unit must remain at its original installation address.
- L. Thermo Products, LLC. shall not be responsible for any failure due to any acts of God including but not limited to fire, water, storms, lightning, power surges, earthquakes, theft or riots.

FAILURE TO COMPLY WITH ANY OF ABOVE CONDITIONS WILL VOID ANY AND ALL WARRANTIES LISTED ABOVE.

THIS WARRANTY EXPRESSLY SUPERSEDES ALL OTHER WARRANTIES AND OBLIGATIONS OF THERMO PRODUCTS, LLC. NO PERSON HAS AUTHORITY TO ALTER OR MODIFY THE TERMS OF THIS WARRANTY IN ANY MANNER. THERMO PRODUCTS, LLC ASSUMES NO LIABILITY FOR CONSEQUENTIAL DAMAGE OF ANY KIND, AND THE PURCHASER BY ACCEPTANCE OF THIS EQUIPMENT ASSUMES ALL LIABILITY FOR THE CONSEQUENCE OF ITS USE OR MISUSE BY THE PURCHASER, HIS EMPLOYEE OR OTHERS.
